01 Apologies for absence

There were no apologies for absence

02 To declare any pecuniary interests and other significant interests relating to items on the agenda.

03 To agree and sign the minutes of the previous meeting, held on 14th December 2022

The minutes were agreed as a true and accurate record of the meeting and were duly signed by the Chairman.

04 Matters arising from the previous minutes

Cllr J. Kirk asked if the PCC had applied for a faculty to install a flagpole in the Churchyard.

Cllr Bartlett confirmed that the faculty had indeed been applied for; but he added that the church authorities may well take some time to respond.

05 Public participation – adjournment of the meeting

There was one member of the public present.

06 Highways

Road safety in Durlock Road (Cllr Trevor Bartlett):

A member of the public asked whether there was any news about the possible introduction of assisted transport for local residents: Cllr Loukes replied that he did contact the transport hub in Deal, and they would welcome Staple joining their transport hub. The Staple part of the hub would operate from this village. People would pay 50p per mile to go to a destination. This should work out cheaper than a taxi. An article concerning this matter will be put in the Escalop. It has already advertised on Facebook and the Parish Council's web site. Appointment times will be able to be arranged in advance.

Mention was made of the potholes in Durlock Road: KCC Highways department is responsible for mending the potholes. The Parish Council are aware of the problem. It was agreed that it would be helpful for the Parish Council to inform residents of the correct authority to whom such problems should be reported. Councillors reiterated that the potholes should be reported as soon as possible to KCC Highways. Clerk to write to the developers of the Mill Lane development to remind them that the road verges should be maintained.

The lack of lighting in Durlock road was mentioned; the matter was not brought up at the DDC meeting last week, owing to lack of time. The subject will be brought up at February meeting. Cllr. Bartlett mentioned that the road actually starts in Ash. Councillors resolved to register their concern with Keith Watson at DDC.

Regarding the A257 meeting, Cllr Loukes said he would attend the meeting. The interactive signage is still not working.

Mention was made of the potholes in Barnsole Road: It was agreed that these would be flagged up to DDC by the Parish Council.

The poor condition of Barnsole Road, including the verges was also discussed.

Cllr J. Kirk requested that DDC Planning be approached and asked to contact the contactors, to remind them of the need to minimise mud and debris on the roads caused by the building works; and also to remind them of the need to repair/reinstate the verges post-construction. It was agreed that this would be done.

The precept demand was discussed. Various matters were discussed, and a great deal of discussion took place about items that would require funding, particularly the HIP (Highways Improvement Plan). There was no application made to increase the Precept last year or the year before. However this year, in light of the safety concerns raised by members of the public, and the need to pay for any improvements in relation to the HIP; an increase in the Precept was deemed necessary in order for the changes to be put into place. The improvements will be phased in over a period of 2-3 years. It was decided that the Parish Council should request a precept of £9464.00. Subsequent expenditure of the precept will be prioritised for safety improvement projects.

Village Hall and Recreation ground

The gas boiler was checked for safety as it is every year. Various maintenance issues were mentioned concerning the boiler and the cooker.

SID/Speed Watch (report has been circulated)

Cllr Loukes mentioned various matters concerning Speed Watch and speeding cars through the village. The SID pole was mentioned: The pole has been lost by KCC. We are waiting for KCC to come back and replace the pole. If we hear nothing after a month, then Cllr Loukes will contact the necessary authorities to ask when it will be replaced. The SIDs and Speed Watch will be reactivated in February.

Footpaths

A letter has been received regarding the reinstatement of the footpaths that have been ploughed up. The weather will hinder any reinstatement. Cllr Coulson will send the farmer a reminder.
