MINUTES OF THE STAPLE PARISH COUNCIL MEETING

Held on Wednesday 13th November 2024 at 7.30 in Staple Village Hall.

PRESENT: Cllrs Bartlett (Chairman), Kirk, Loukes, Davis-Marks, Martin and Ewart.

Cllr Loukes took notes as acting Parish Clerk.

IN ATTENDANCE: There were 6 members of the public in attendance. Cllr Martin Porter(DDC) and Cllr Sue Chandler (KCC) were also in attendance The Chairman welcomed everyone to the meeting

- APOLOGIES FOR ABSENCE ~ prospective co-opted councillor Nigel Rogers-Hudson.It was proposed by Cllr Loukes and seconded by Cllr Ewart that Nigel Rogers-Hudson be co-opted; accepted by the Parish Council with no objections.
- 2. DECLARATIONS OF INTERESTS. Cllr Kirk and Martin for Planning (Item 5)
- 3. Minutes of previous meeting held in October were accepted and signed.
- 4. PUBLIC SESSION
 - a. No one from Elivia attended
 - b. DDC evictionofficer did not respond to a request to attend.
 - c. A member of the public had sent request to KCC to attend toBarnsole Road where the road is badly eroded. KCC Roads Ref 840720 (10th November) Sue Chandler will follow this through.Cllr Porter will check the rules with DDC regarding the reinstatement of roads after houses are completed. It was noted that the builder will be off site by Dec 22nd.
 - d. Staple Face Book pages. Note those that are open. One has been stopped but two others are still continuing –Staple Facebook Group and Staple Facebook Group Local businesses.
 - e. Mill Road. Enforcement notice from May taken down. Second enforcement rejected. Going to reissue another enforcement notice but cannot as DDC Planning department (covering eviction notices) overloaded and appeal is going through. The PC has writtena draft letter to Ombudsman which will be circulated for approval. Elivia will also be writing a letter of complaint.
 - f. Summerfield travellers' site There is a planning application with DDC for one house, but their recommendation is for refusal. The application will be considered on 21st Nov. The PC need to support one house but only one person can speak for 3 mins to appeal to overturn refusal. Trevor will check with Woodnesborough whether they will attend.

- h. Clerk's expenses not paid ~ backpay and working from home £68:71 **All finance items approved**.Proposed by Cllr Davis-Marks and seconded by Cllr Ewart.

6. REPORTS

- a. District Councillor ~ forwarded to be included in the Escallop
- b. County Councillor Household support Fund some funds will be distributed by DDC from the sum allocated to KCC, it is noted that many families have not applied for income Support. An Education consultation has been issued for response. Budget being prepared for 2025 – 26. Care companies will be facing problems with payments. This will impact the draft budget. Potholes – blitz now finished. Gritting - KCC is ready for the winter. PC should check that our salt bins are full – any lack of salt can be reported via KCC reporting site. KCC looking to support Ukraine - at no cost to KCC - cooperation, advice and voluntary support. In DDC Libraries there is lots going on in Dover including winter coat exchange – need to let them know if anyone has a coat they can donate. Kent plant trees initiative – KCC are asking all landowners if they have an area to plant trees – free supply – with landowners to maintain. A question was asked on support for Private Care companies – Cllr Chandler will get back to Cllr Georgina with information.
- c. Village Hall and Recreation Grounds ~
 - i. update on future of Village Hall usage There is a new booking officer Clare Marsh. The Business plan for the Pre-school was reviewed by the Village Hall Committee but was not considered feasible and therefore will not be progressed at this time
 - ii. reinstate Wi-Fi and Vfastlink Cllr Kirk will look at the possibility so that security can be improved.
- d. Highways (SID, Speedwatch, footpaths) ~ to be included in the Escallop
- e. Planning ~ an update from Cllr Davis-MarksSee Appendix A
- f. Kent Police ~ forwarded to be included in the Escallop
- g. Update on Drains and White lining. The drains have been cleared outside the Old Forge and along Lower Road, but a member of the

public mentioned that the drain at the left-hand side of the Hollies looks like it is still full of mud. The white lines from Lower Road to Grove Road have been redone and may help in keeping cars to their correct side of the road at the Old Forge corner
